

GUIDELINES FOR THE AUTHORS

Shivip Publications LLP welcomes original research papers from both academics and practitioners. Papers based on theoretical/empirical research and experience should satisfy good quality research and must reflect the practical applicability/policy implications of the research. Shivip Publications covers national and international journals namely, International Journal of Contemporary Engineering and Technological Development (IJCETD); International Journal of Vedic Management (IJVM); International Journal of Intellectual Rights and Management (IJIRM); International Journal of Engineering, Technology and Innovation (IJETI); International Journal of Contemporary Legal Studies (IJCLS); International Journal of Contemporary Business Management (IJCMB); International Journal of Business Studies and Insights (IJBSI); International Journal of Business Analytics Applications (IJBAA). All the journals are 'double-blind peer reviewed journals'.

Manuscript Submission

1. The Manuscripts should be in MS-Word format. Manuscripts must be double spaced, with 1-inch margins with "Times New Roman, Font Size 12, black".
2. It is mandatory to mention a valid email address with content submitted online. The papers after submissions will undergo Preliminary Editor Review. The papers that clear this Review will be issued an article id. We will acknowledge the receipt of your manuscript by email and an article id will be issued to the corresponding author. The author(s) should keep in mind that it would be mandatory to cite this id while sending a query about the manuscript submitted online. Wherever available, please include author ORCID ids. Two or more referees will review the short listed manuscripts by following the double blind system - that is, with the author's name and credentials deleted, so that the reviewers don't know who is authoring the work.
3. In the first page of the paper (cover page), please provide full names (first, middle and last names), designation, name of department and full addresses (Institute's address along with designation and correspondence address) along with email address of the author(s). The author's name or affiliations should not appear anywhere else in the body of the manuscript, because our peer-review process is blinded.
4. The actual paper should commence from the second page containing the title followed by the abstract, keywords, and the main paper. The author's name should not be mentioned anywhere except in the first page (cover page).
5. The Manuscripts should be between 6000 and 8000 words in length. This includes all text i.e. the abstract, references, all text in tables and figures and appendices. The manuscript should also mention the time period in which the research was conducted.
6. The abstracts should be clear and provide an excellent summary of each article's content reflecting purpose of the study, methodology used, major findings and implications. The Abstract should be written in past tense and should not be more than 300 words. The abstract should only include text. Avoid the use of abbreviations and references in the abstract. The Abstract should be followed by relevant keywords.

7. The manuscript classification should be clearly mentioned with every submission. The manuscript shall be one of the following types for submission. Please choose the best fit in case you does not find a best fit.
 - Research Paper
 - Review Paper
 - Viewpoint
 - Case Study
 - Book Review
8. Tables should be numbered consecutively as Table 1, Table 2, and so on (and not as Table 1.1, Table 1.2, and so on). The title of the table should be placed above the table. The source should be indicated at the bottom. Please provide table(s) as real table(s) with rows, columns and cells. Each piece of information should reside in its own cell.
9. Figures should be numbered consecutively (as Figure 1, Figure 2, and so on and not as Figure 1.1, Figure 1.2, and so on). Wherever necessary, the source should be indicated at the bottom. The figures should also be given relevant titles.
10. All tables, charts, graphs, diagrams should be black and not in color. The images should be of high resolution and in black and white only. Number and complexity of such exhibits should be as low as possible. All charts and graphs should be drawn legibly and figures should be indicated in millions and billions.
11. References should be included at the end of the paper. All the references should be cited in the body of the text. References and citations should be complete in all respects and arranged in alphabetical order.
12. Display formulae and mathematical equations should be numbered serially. Equations should be typewritten.
13. Footnotes, italics, and quotation marks should be kept to the minimum.
14. The primary heading should be in capitalized form (Uppercase), and boldface. The sub-headings should be in title- case capitalization (first letter of each word in capital) and in bold.
15. Manuscripts not accepted for publication will not be sent back to contributors. Contributors whose papers are accepted or rejected will be informed by email only. Hence, it is mandatory to mention a valid email address with the submitted content.
16. **We will not accept hard copies of the manuscripts for publication process.** Kindly click on 'Submit Manuscript' to submit your paper online. The paper has to be submitted in MS-Word format only. There is no charge for submitting papers for blind review.
17. Authors should be careful while submitting papers for review. Please read about the scope and topics covered by our each title, and then make the submission. Please do not make multiple submissions of one paper to our other titles.

Copyright

To enable the Publisher to protect the copyright of the journal, the corresponding author must send a copy of the Copyright Transfer Agreement for Review process available on the website (when a paper is submitted for review). Only the Copyright Transfer Agreement needs to be submitted when a paper is being submitted for review and possible publication in the selected Journal of Shivip Publications LLP.

Review Process

1. After a paper is received it is verified and checked by the editor. They may choose to decline or unsubmit your manuscript if it doesn't fit the aims and scope of the respective Journal or they feel the language/manuscript quality is too low.
2. If they think that the manuscript might be suitable for publication, it will be sent to at least two independent referees for double blind peer review. After their feedbacks, the editor shall decide to accept your manuscript, request for minor or major review, or decline the manuscript.
3. This whole process shall take some time between 45 days to 90 days from the date of submission. However, in case of any development, the corresponding author shall be informed through email.
4. The Editor-in-Chief and Managing Editor reserve the right to accept or refuse an article for publication, without assigning any reasons.
5. After the review process is completed, the authors will be informed about the decision of the reviewers by email.

If your Submission is accepted

1. If a paper is accepted for publication, the authors will be informed by email about the acceptance.
2. If the paper is accepted for publication, then the authors are required to remit a processing fee (to be paid by any ONE author - this clause is applicable only AFTER a paper is accepted for publication).
3. An electronic version of the accepted manuscript would be sent to the corresponding author for final reviewing and correcting any typographical errors, grammatical errors or incorrect author details. We will not accept requests to rewrite texts at this stage in any condition.
4. Each author of the paper will have to sign and self-attest the Copyright Transfer Agreement form and the scanned copy of this form has to be submitted to the Editorial Office of Shivip Publications LLP through respective journal email.
5. Copyright of published articles will rest with the respective journals of Shivip Publications LLP.
6. The final draft is subject to editorial amendments to suit the journal's requirements.

Referencing

References and citations should be complete in all respects in order to enable readers to look up the source materials and most importantly, to demonstrate that your paper is well-researched and gives credit to the author(s) of the source materials. References should be included at the end of the paper. All the references should be referred to in the text and arranged in alphabetical order. Authors are requested to include only a list of *cited References* and not a *Bibliography*. Reference to a citation in the text should be made by means of the author's name followed by the year of publication in parenthesis. The references must follow the style guide of the *American Psychological Association (APA)*.

All references in your manuscript must be formatted using the American Psychological Association (APA) format Seventh Edition. Authors are advised to go through the APA 7th edition style referencing and accordingly arrange the references in the manuscript.
